**Payment of the Bills**: Motion by Gonzalez, second by Baker to approve payment of the bills in the amount of \$23,207.90 All ayes; motion carried.

**Employee Wage Report:** Total Gross Wages from April 1 – 30, 2021 were \$13,131.23 gross and a total of 661.77 hours worked for all regular Village Employees.

**2021Tax Levey:** the Hedley amendment decreased the millage this year and capped it but the taxable value increased. Motion by Gonzalez, second by Baker to have the levy without a hearing or compliance (the lowest option) will increase the mills by \$6,514.45 overall.

Utilities Report: is still not 100% accurate.

Police Department: No report was available due to computer trouble.

## Administrative:

1. 3 Ordinances for Adult Use Marihuana and a Permit were drafted by the Village Attorney for Adult Use Marihuana Provisioning Center. The Planning Commission held a Public Hearing on April 6, 2021, no members of the Public attended. The Village Attorney and the Zoning Administer were in attendance, the Zoning Administer had suggested several changes, the Planning Commission met again on April 27, 2021 and reviewed the changes and recommended the Ordinances to the Council. The Council read over the changes and voted by roll call vote on all 3 of them: Motion by Gonzalez to hold a roll call vote on Ordinance 2021-1; an Ordinance to amend the Village code of Ordinances Title XI, Businesses regulations by adding Section C, Adult Use Marihuana. Ordinance 2021-2, an ordinance to a new subsection G under the Village Zoning Ordinance 2015-1, Article VIII entitled "CBD-Central Business District", Section 8.03 entitled "Uses permitted by special use permit". Ordinance 2021-3, an Ordinance to add a new subsection J under the Village Zoning Ordinance 2015-1, Article IX entitled "I-Industrial District", Section 9.03 entitled "Uses Permitted by Special Use Permit". Second by Rice. Roll Call Vote:

All Ayes, Ordinances 2021-1, 2021-2 and 2021-3 all ayes, All Ordnances are effective 20 days from the date of publishing.

Water/sewer/solid waste: Lead & Copper testing is ongoing in the Village; it has still not been found in the Village water system.

Planning Commission: No new business.

**Streets:** Several stop signs in the Village are very faded and need to be replaced such as Main & Elm, Grace & Pipestone. The Public Works Dept. has a few stop signs in back they can put up.
