**Copy Machine:** The lease on the Kyocera Copy machine will be up in March 2022. Tabled.

Phone Bills for the Alarms in the lift stations & pump house. The Clerk has been trying to renew these contracts since June of 2022. Suggestion to contact MEC to see if they can provide phone services for them.

**Short Term Rentals:** The Village looked at a sample ordinance and will refer this to the Planning Commission.

**Broadband Grant:** The Village sent in their own Grant Application, but has since found out that the Townships have included the Village.

**Billing for changing of the Marihuana Ordinance:** was sent to Michigan Total Healing for \$2,495.17 for the cost of the meeting, publishing of the meeting notice and ordinance and attorney fees.

**Committee Appointments:** Pro Tem: Gonzalez, Water/Sewer/Solid Waste Committee: Gonzalez & Karn. Administrative/Personal/Police: Gonzalez & Karn. Streets: Keesler, need one more.

Finance/Budget: Glassman, Borkowski, Foster, Gonzalez. Planning Commission: Chair Ferguson, Karn Jr. & Zeilke. Library Board: Walker 7 Stanczyk.

**Japanese Knot Weed:** a highly invasive non-native plant that thrives in wet areas. Methods of eradication gone over, if you cut it, it spreads more. Certain companies and methods are used.

**Parks:** Blankenship's Property Maintenance are edging the walking trails and other locations in the Village. There is a washout area where gravel will be added near the trail. There have been complaints of dog waste on the trails, the Village will order signs. The trails are for pedestrians only, Dirt Bikes, ATV's and Golf carts or other vehicles should not be on it.

**Water/sewer/solid waste:** Still waiting for a plan to finish installment. The Clerk will contact Town & Country Plumbing to see if they can finish and at what cost.

**Planning Commission:** Needs two members. Next Planning Commission Meeting to be held, November 15, 2022 at 6:30 PM.

**Streets:** Act 51 monies received from the state for streets, every 10 years the Village must spend \$10,000 on none motorized street improvements, such as replacing sidewalks, bike paths, signs, the council is working on a list, this must be completed by 2024.

Digital Radar signs will be ready for installation soon.

**ROW permits:** ROW permits tabled, Planning Commission to review them.

**Equipment:** No new business.

Sanitation: Contracted rates with Bestway will have a slight increase in March 2023.
