Finance/Treasurer's Report: Departmental Balance Report 08/01/2022 – 08/31/2022

Payment of the Bills: Motion by Karn, second by Rice to approve payment of the bills in the amount of \$21,720.83 All ayes; motion carried. The preauthorized bills amounted to \$4,435.20.

The Clerk noted that the Village has not received the sanitation billing from Bestway yet this month. **Employee Wage Report:** Total Gross Wages from August 1 - 31, 2022 were \$21,129.89 with a total 960.35 hours worked for all regular Village employees and includes Village Council & Planning Commission Pay for the quarter.

Utilities Report: Current amount due for Water/Sewer/Sanitation from 08/11 – 09/10 2022 is \$34,648.49 this includes late fees that are due as well.

Annual Audit: Derek Hall gave a report on the Village funds, everything was good on the audit Police Department: Report 08/15/2022 – 09/19/2022. 4 warning tickets and 7 Incidents. Administrative:

F & V continue to work on the O & M manual for the Lagoons as well as Groundwater monitoring. Kathy Zielke was sworn in to the Village Council for the remainder of the term until November 14, 2022, she will also be running as a write-in candidate for the 8th 2022 Election.

Parks: Blankenship's Property Maintenance will be edging the walking trails and other locations in the Village.

Water/sewer/solid waste: Several commercial meters need to be replaced with the new drive by meter and two need repairs and a few still need to be reprogrammed. Clerk to find out what other

towns in our area are using Badger Meters. The Clerk has tried to find a company that can finish the project.

Planning Commission: Needs two members.

Streets: Act 51 monies received from the state for streets, every 10 years the Village must spend \$10,000 on none motorized street improvements, such as replacing sidewalks, bike paths, signs, the council is working on a list, this must be completed by 2024.

ROW permits: ROW permits tabled

Equipment: No new business.

Sanitation: No new business.
